The Government of Tajikistan has received financing from the World Bank toward the cost of the Strengthening Resilience of the Agriculture Sector Project (SRASP) and intends to apply part of the proceeds toward payments under the contract for Procurement of IT equipment, office furniture and 136 sets. of field bags with instruments for the Committee of Food Security and SUE "Center for Digitalization and Professional Development of Agriculture Personnel".

The State Institute "Agriculture Entrepreneurship Development" Project Management Unit now invites sealed Bids from eligible Bidders for: Lot #1 – Procurement of IT equipment for Committee of Food Security, SUE "Center for Digitalization and Professional Development of Agriculture Personnel" and SI AED PMU staff, Lot 2 – Procurement of office furniture for Committee of Food Security and SUE "Center for Digitalization and Professional Development of Agriculture Personnel", Lot #3 – : Procurement of 136 sets. of field bags for seed analysis for Committee of Food Security.

3. Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" dated

July 2016, revised September 2023 (“Procurement Regulations”) and is open to all eligible Bidders as defined in the Procurement Regulations.
