The Government of Tajikistan has received financing from the World Bank toward the cost of the Strengthening Resilience of the Agriculture Sector Project (SRASP) and intends to apply part of the proceeds toward payments under the contract for office furniture and IT equipment for the Tajik Academy of Agricultural Sciences (TAAS) institutes and SI "Plant protection and Agricultural Chemicals".
