On July 12, 2023, a round table on "Promotion of Wheat Flour Fortification Initiative and establishment of the National Premix Revolving Fund" was held in the hall of the National Library. The event included a presentation of sub-component 3.4 of the Strengthening Resilience of the Agriculture Sector Project on "Improving Nutrition", with the participation of Project development partners and nutrition specialists.

The director of SI "Agricultural Entrepreneurship Development" Mr. Daler Satori highlighted in his introductory speech that the round table was being held as part of additional funding of Strengthening Resilience of the Agriculture Sector Project which included support for food fortification measures.

Then, according to the program of the event, the participants of the round table — representatives of interested ministries and sectoral agencies, discussed and presented their recommendations on the main directions of activity of the National Premix Revolving Fund and food fortification.

The Multisectoral Plan of Action for Nutrition in the Republic of Tajikistan for 2021-2025, which is aimed at the practical implementation of health, food security, social protection, school nutrition strategies, as well as the Law "On Providing the Population with Fortified Foods" and the National Communication Program for the "First 1000 Days of a Child's life in the Republic of Tajikistan for the period 2020-2024" and a number of programs, provides for specific tasks and activities aimed at improving the nutrition of the population, especially mothers.

The round table, where priority problems of supplies of fortified flour and iodized salt were discussed, was productive. As a result of this event, it was decided to hold regular meetings of the working group on healthy nutrition in

the Republic of Tajikistan in the future.



August 15, 2023

On July 6-7, 2023 within the framework of the implementation of Strengthening Resilience of the Agricultural Sector Project a seminar was held to discuss the results of the first half of the year 2023 with the participation of the management and staff of the State Institution "Agricultural Entrepreneurship Development".

Daler Satori, Director of the State Institution "Agricultural Entrepreneurship Development", noted in his opening speech that the discussion of the results of the Project's activities for the first half of the year is envisaged by the work plan. B. Kurbanov, Deputy Director/Project Coordinator, coordinators of the Project components, specialists in procurement, finance, ecology and social work, evaluation and monitoring made presentations on the results achieved at the seminar.

It was noted that the Additional Financing Agreement was signed in early 2023 and the number of project beneficiaries has increased.

At the end of the seminar, the specialists were tasked to improve activities in the subsequent second half of the year.

August 15, 2023 **High harvest is guarantee of food security**

Under sub-component 1.3: Reproduction of seeds, seedlings and planting material, elite wheat varieties such as "Grom", "Alekseich" and "Bezostaya-100" were distributed among seed farms.

The objective of this sub-component is to build the capacity of public and private seed farms and nurseries engaged in reproduction of seeds, seedlings and planting materials and to establish distribution centers along value chains to process and sell high quality seeds, seedlings and planting materials produced for farmers. State seed farms and nurseries will be supported to improve their facilities and human capacity, while private seed farms and nurseries, including those managed by cooperatives, will benefit from human capacity building, including technical assistance. State seed farms include facilities managed either by TAU or research institutes affiliated with TAAS, while private seed farms and nurseries include facilities owned and operated by private organizations that are engaged in reproduction of seeds, seedlings and planting material in the Republic of Tajikistan.

August 15, 2023

Consultations for farmers

Within the framework of the first component of "Strengthening Resilience of the Agriculture Sector" Project it is envisaged to improve seed network, nurseries and inputs (seeds, machinery, mineral fertilizers, etc.).

In order to ensure adequate access to quality seeds, seedlings

and marketable production materials that are adapted to local conditions, resistant to climate change and available to farmers for seed distribution, specialists of the State Institution "Agriculture Entrepreneurship Development" provide useful consultations to representatives of farms.

Quality wheat, potato and cotton seeds with the addition of mineral fertilizers have become available to the farms of the republic, from which abundant yields are subsequently obtained.
