June 16, 2025 PUBLIC HEARINGS ON STARTING THE AGROLOGISTIC CENTER CONSTRUCTION IN SUGHD REGION

The agricultural sector development is considered one of the Republic of Tajikistan Government priority directions to provide the population with food, develop industry and improve the economic status of compatriots.

On June 13 this year, the State Institution "Agriculture Entrepreneurship Development" in the framework of the "Strengthening Resilience of the Agriculture Sector Project" specialists on social and environmental issues held public hearings with participation of responsible persons from the Sughd region State Authority Executive Body, residents of neighborhoods next to the construction site and the construction company "Termodynamika" employees involved in the construction.

The hearings were opened by the head of Sughd region State Power Executive Body Department of Investment and Property Sharifjon Akhmedov, who in his speech told about the progress of agrologistic center construction in the region free economic zone and stated that the region State Power Executive Body responsible persons are ready to provide all-round support for its timely construction.

Afterwards, Rano Rakhmatova, AED PMU specialist on social issues, spoke about the Republic of Tajikistan Government continuous support in the agrarian sector development, the benefit of agrologistic centers for the country population in providing permanent jobs and about the progress in the SRASP implementation, considering the upcoming plans fulfillment for this facility construction using modern technologies for its qualitative and timely completion.

During the hearings, the "Termodynamika" construction company engineers made informative presentations and provided their work plans to the audience from the beginning of a large-scale construction project to the completion.

At the end of the hearings, the specific instructions and tasks were given to the responsible persons for the upcoming construction timely implementation. June 16, 2025 IMPROVING ACCESS TO WATER UNDER THE "STRENGTHENING RESILIENCE OF THE AGRICULTURE SECTOR PROJECT"

The State Institution "Agriculture Entrepreneurship Development" within the "Strengthening Resilience of the Agriculture Sector Project" framework is starting to implement new plans in various areas of agriculture development.

This year, within the project framework, the institution plans to drill 5 wells to irrigate the unused lands of the Ministry of Agriculture and the Academy of Agricultural Sciences of Tajikistan scientific institutions. To date, 3 wells have been fully put into operation and 2 are at the completion stage.

Besides, in order to provide vulnerable farms in the country with water, a project to drill another series of wells is currently at the stage of technical and economic assessment and costing, and drilling works are expected to be implemented this year.

At present, drilling a well to enrich the lands of the State Unitary Enterprise "Seed and Vegetable Varieties of Tajikistan" branch in Khujand and the State Enterprise "State Crop Variety Testing and Variety Protection Station" in Istaravshan district has been completed; installation of protected cables to transformers, electricity meters and well pumps is on time and will be completed in the coming days.

The institution specialists checked the works progress and gave useful recommendations to the workers engaged in installation and wiring works on compliance with safety rules, labor protection and sanitary norms in order to meet the Republic of Tajikistan current legislation and the World Bank requirements.

June 16, 2025 MONITORING THE FIELD WORKS PROGRESS IN KHATLON REGION

This week, specialists of the State Institution "Agriculture Entrepreneurship Development" familiarized themselves with the farmers (project beneficiaries) seasonal work in Khatlon region.

The field work in the region towns and districts continues enthusiastically: farmers are collectively engaged in harvesting onions, inter-row cotton cultivation, irrigating corn, weeding and perching various crops, as well as watering and fertilizing.

They have already started harvesting crops, especially wheat, vegetables, legumes and fruits, supplying agricultural products to the domestic market as well as seeking to export them.

In addition, the AED PMU specialists gave useful advices on timely and safe harvesting of these crops and sowing the other ones in their fields.

June 16, 2025 PROGRESS OF TESTING THE GRAIN CROPS IN THE SUGHD REGION

Every year, agriculture specialists implement testing to determine the biological yield of agricultural crops.

Specialists from the State Institution "Agriculture Entrepreneurship Development" within the framework of the "Strengthening Resilience of the Agriculture Sector Project" together with specialists from the Ministry of Agriculture and the Food Security Committee began testing the grain crops in the Sughd region.

During testing, the team determines the expected biological

yield and takes measures to implement the long-term plan.

Specialists started the testing work in the fields of the Sohibjon farm of J. Rasulov district and the Ravshanbek farm of Shahriston district.

It should be noted that this year, as part of the "Strengthening Resilience of the Agriculture Sector Project", farm managers received high-quality certified seeds of the "elite" category from the institution, varieties Timiryazevka 150 and Alekseich distinguished by high yield and adapted to local climatic conditions.

During testing, it was determined that farmers (project beneficiaries) implemented agricultural work in a timely and high-quality manner, which will enable a high wheat yield of 60-65 c/ha in future
